FM HD Power Levels subject of September webinar

In 2010, the Federal Communications Commission adopted new technical rules to permit FM stations to voluntarily increase hybrid digital power levels from -20dBc to -14dBc for most stations, and set a system to allow some stations to achieve up to -10dBc. Since that date, many stations have updated their transmission facilities to take advantage of the power increase. Most automotive manufacturers are including HD Radio in many of their latest vehicles.

The next SBE webinar "Field Observations of Elevated FM HD (IBOC) Power Levels" on Wednesday, September 24th from 2 to 3 p.m. ET, will present some of the tangible benefits of elevated digital power, as well as some of the shortcomings to help engineers better understand digital radio coverage and performance at various power levels.

Presenting this SBE webinar is Alan Jurison, CSRE, AMD, DRB, CBNE. Jurison is a senior operations engineer in the corporate Engineering and Systems Integration Group of Clear Channel Media and Entertainment. Changes to FCC rules for Tower lighting by Tom Smith [sbe24]

On August 8th, the FCC adopted and released a Report and Order (http://transition.fcc.gov/Daily_Releases/Daily_Business/2014/db0808/FCC-14-117A1.pdf) concerning the rules for tower registration and maintenance.

The purpose of the rulemaking was to harmonize its rules with the FAA's. Changes include the FCC adopting the FAA no-hazard determination, in most instances for antenna structures lighting and marking requirements, and eliminate its references to older FAA circulars in Part 17 of the FCC's rules. The FCC reserves the right to add additional or different requirements if they determine there is an aviation hazard.

- They will not require updating to new lighting standards unless the FAA mandates it. Conservation groups wanted the FCC to mandate that steady burning sidelights be extinguished as a result of a FAA study on side markers and bird deaths. The FCC will wait on this issue until the FAA makes a final determination on this issue.
- There are many other rule changes.
- They include requiring an application for a new Antenna Structure Registration (ASR) when changing the height of an antenna structure by one foot or more and changing the location by one second or more,
- changing the notification period for ownership changes and completion of construction or dismantlement from 24 hours to five days and continue to allow voluntary registration of towers that normally do not require registration.
- The FCC will only require the posting of the Antenna Structure Registration at all entrances to the tower site for single tower facilities. Multiple tower sites will require the posting of the ASR at the entrance and at each of the towers. Tower owners will now be allowed to e-mail or use other electronic means to notify tenants of an ASR change by providing a link to a copy of the registration instead of providing a paper copy.
- There were changes to the monitoring requirements of lighting systems with the elimination

of the quarterly light system inspection, if there is a robust monitoring system that can notify a manned operation center 24 hours a day of lighting failures. Also, they eliminated the rule requiring the FAA being notified by telephone or telegraph of a lighting failure.

- Notification of a lighting failure will now be subject to means that are acceptable to the FAA which is currently a toll-free telephone number. Any notification of a lighting failure must be renewed every 15 days if not repaired. The FCC declined to set a deadline for making lighting repairs but stated that they should be made as soon as practicable.
- Lighting monitoring logs must now be kept for two years. There was no retention period in the rules other than the logs had to be saved.
- Finally, the FCC adopted the FAA's "In-Service Aviation Orange Tolerance Chart" as a reference for checking paint on a tower. To determine if the tower needs to be repainted the paint color on the upper half of the tower should be compared with colors on the chart. The rule changes should make many tower regulations easier to understand and to comply with. Tower owners should check the new rules to see what changes affect them.


